What is Live Scan Fingerprinting?

Live Scan is a system used for the electronic submission of applicant fingerprints to the Department of Justice (DOJ). Live Scan is a computer digitized fingerprinting that replaces the process of recording fingerprint patterns through a rolling process using ink. This system allows for the electronic transfer of fingerprint image data to DOJ in a matter of seconds, instead of the days required to send print card through the mail. This system also allows for the results to be received within days, versus seven to ten weeks required for a print card.

Who needs Live Scan?

If a requesting agency does not have results yet (10 business days, after your fingerprints taken), then you can use the automated telephone system to check on your submission. You will need the following information ready:

- (1) Your date of birth; and
- (2) The 10-digit Automated Transaction Identifier (ATI) number that appears at the bottom of the live Scan Fingerprint request form, written by Livescan Operator.

The ATI number always appears in the following sequence:

1 LETTER; 3 NUMBERS; 3 LETTERS and 3 NUMBERS.
